

**NABH- Entry Level Assessor Training Programme**  
**(For Assessments of Healthcare Organizations)**

NABH proposes to have a three days entry level assessor Courses in the following cities:

1. Ahmedabad – 14th – 16th June 2019
2. Mangalore – 21th -23th June 2019
3. Raipur – 28th -30th June 2019

**Course details and fee:** The course is non-residential and the participant has to attend on all the three days. The course involves interactive teaching & exercises. The evaluation of the participants will be based on the daily monitoring of performance and a written examination. The successful participants would be considered for empanelment as NABH assessors. The fee for the training course is **Rs. 17,700/- included 18% tax** which also includes lunch & tea for 3 days. The copy of NABH standard and the course as study material will be provided at the venue. All payments to be made by Demand Drafts in favor of '**Quality Council of India**' payable at **New Delhi**.

**Eligibility Criteria for applying for NABH Entry Level Assessors Course:**

**For clinician:** Post-graduate or MBBS with 10 years of experience of which 5 years should be in a hospital. Higher qualification in clinical branches will be preferable.

**For Administrator:-** Post-graduate in Hospital Management with prior MBBS qualification and a minimum of 10 years of experience of which 5 years being in the hospital administration at senior management positions. Higher qualification will be preferable.

**For nursing assessor:** M.Sc. or B.Sc. Nursing with 10 years of experience. Minimum of 5 years should be in an organization-wide supervisory capacity in the hospital. Higher qualification will be preferable.

**Desirable criteria for all categories:** - Experience of at least one year in implementation of NABH accreditation standards in their organization. Candidate with higher experience than the minimum will be preferred. Candidates having successful completion of POI on NABH Accreditation Standards or entry level standards are desirable. Participants should be proficient with the requirements of the NABH standards and interpretation.

*Only shortlisted candidates will be informed by email and ask to submit the Scanned Copy of Graduation and post-graduation certificates along with Fee.*
