NABH as an organization has been accredited by International Society of Quality in Healthcare (ISQua) under its External Evaluation Accreditation (EEA) programme following an independent assessment against the Guidelines and Standards for External Evaluation Organisations, 5<sup>th</sup> Edition since the year 2012.

**The previous cycles of accreditation are as below:**

September 2012 - August 2016

August 2016- September 2020 (*extended till July 2022 during to COVID-19 pandemic*)

The current accreditation has been granted from the period of June 2022 to June 2026. This is the third cycle of ISQUA EEA accreditation of NABH.

NABH Hospital accreditation Standards, 5<sup>th</sup> edition have also been accredited by International Society of Quality in Healthcare (ISQua) under its External Evaluation Accreditation (EEA) programme. The current accreditation cycle for accreditation of Hospital accreditation Standards, 5<sup>th</sup> edition is from the period of April 2020 to April 2024.

April 2008 – March 2012- 2<sup>nd</sup> Edition

April 2012 – March 2016- 3<sup>rd</sup> Edition

April 2016 – March 2020 – 4<sup>th</sup> Edition


